

Its holistic model of education, conceived and enriched by its illustrious founder, offers refreshingly new perspectives to young minds and nurtures and facilitates their creative talents.


### The Founder's Vision

### The University

This university was conceived as a residential university, keeping in view its objective of complete character development and thorough mentoring of students. Perhaps this is the only university in the world where courses ranging from nursery and primary school upto Doctoral/ Post-doctoral degrees are taught and pursued within a walled campus spread over 550 Hectares (1360 acres) and having majestic buildings of great architectural delight. It enshrines within its precincts, a phenomenal range of teaching disciplines incorporating almost all conceivable subjects of Science, Engineering & Technology, Medical Sciences, Humanities, Social Sciences, Commerce, Law, Education, Visual Arts, Performing Arts, Sanskrit VidyaDharm Vigyan, Agriculture, Veterinary Sciences, Library Science, Journalism and a large number of Indian and Foreign Languages.



There are at present 5 departments receiving support under Special Assistance Programme, 7-UGC-Innovative / TRIEA / Other Programme and 3-DST-FIST (Fund for Improvement of Science & Technology) 4 departments/schools are supported under FIST 3 Programme of DST. It also has four colleges admitted to the privileges of the university which are located in the city. The university also

runs three schools apart from having a Kendriya Vidyalaya housed in the Campus. In addition, the Rajiv Gandhi South Campus has been established in the year 2006 in a sprawling campus of 1092.6 Hectares (2700 acres) located about 75 kms away from the main campus, at Barkachha in Mirzapur district, Uttar Pradesh.

#### Hallmark of Excellence

In NIRF Rankings, Banaras Hindu University has been ranked 3<sup>rd</sup> among the universities and 10<sup>th</sup> among higher education institutions in the country for consecutive 5 years

#### **Institute of Agricultural Sciences**

Committed to the objectives of holistic, sustainable and equitable development of agriculture and allied sciences, aimed at liberty, security and prosperity through competent human resource development by virtue of integrated approach of teaching, research and extension, determined for creation of knowledge base for the benefit of the farming community, improvement of crops/ vegetables/ fruits/ livestock/ poultry/ fish for enhanced input use efficiency & production, and committed for quality seed production and dissemination of proven technologies towards



improving livelihood security and realizing the dream of Hunger Free Society, our achievements in Education (including Sports and Cultural activities) and Research (including Extension activities) justify the funds sanctioned, created and generated from time to time.

#### **Institute of Medical Sciences**

The Institute of Medical Sciences comprises three faculties, namely, Faculty of Modern Medicine, Faculty of Ayurveda, and Faculty of Dental Sciences. It offers medical and paramedical courses at undergraduate and postgraduate levels. Through its hospitals, it caters to the clinical needs of more than 20 crores population hailing from 7 states (UP, Bihar, West Bengal, Jharkhand, Odisha, Chhattisgarh and Madhya Pradesh) and neighboring countries like Nepal and Bhutan. More than 40% of the patients visiting the hospital are from low economic strata. At present, the hospitals have 2614 beds which includes 1385-Bed Sir Sunderlal Hospital; 180-Bed Ayurveda Wing; 334-Bed Trauma Centre; 13-Bed Dental Science; 430-Bed Centenary Super Specialty Block; 100-Bed Mother & Child Health Wing; 60-Bed Centre of Excellence for Mental Health; 12-Bed Bone Marrow Transplant & Stem Cell Research Centre and 100 Bed Regional Institute of Ophthalmology.



#### Institute of Environmental and Sustainable Development

A national-level Institute of Environment & Sustainable Development was established in the year 2010. Recruitment of faculty was done in the year 2011. Using education as a tool to achieve

sustainability, the institute aims to cover education for sustainable development. Mission of the Institute is to carry out teaching, research and extension relevant to India's sustainable development leading to the future that ends poverty and delivers and sustains efficient and equitable management of the country's natural resources.

#### **Institute of Management Studies**

The University started Post Graduate and doctoral program in Management in the year 1968 as a Department in the Faculty of Commerce. Envisaging the increasing need for imparting quality management education and research, the University transformed the Department of Management Studies to an independent Faculty of Management Studies in the year 1984. Dedicated efforts were made to run innovative and need based programs for the corporate world under the dynamic leadership of professors of national and international repute. The Faculty has been upgraded to Institute of Management Studies in December 2015.



#### **Institute of Science**

Established in 1916, the Faculty of Science which later on upgraded to Institute of Science as a constituent institute of the University, offers under graduate and post graduate courses besides offering Ph.D. program and several diploma and certificate courses. The Institute comprises of 13 departments, 6 Centres and 2 Interdisciplinary Schools. Equipped with advanced and sophisticated laboratories and research facilities the institute is marching ahead towards excellence in teaching, learning and research in almost all domains of basic and applied sciences.

#### Largest Residential Campus in Asia

Over 35,000 students from all over India and abroad are enrolled in various faculties of the university. The university has 72 hostels, having nearly 11000 inmates, with all modem amenities

including internet for the students. It also has 1590 staff quarters and 7 guest houses on the campus.

#### Library

BHU has a Central Library system having more than 15 lacs volumes apart from subscription to more than 15000 online journals, 50000 e-books, databases and a huge collection of digitalized rare manuscripts. It functions in conjunction with a chain of Departmental, Faculty and Institute libraries. In addition, BHU has a fully air-conditioned Cyber Library with a seating capacity of over 200. Newly created air-conditioned



Periodical Hall provides 60 cabins for the use of faculty members and research scholars.





#### **ICT Infrastructure**

The University has WiFi enabled campus. All the academic and administrative offices are WiFi connected. In addition, the University has 100 kilometres long fibre optic backbone of campus wide LAN, connecting all academic and administrative buildings as well as hostels with a well-equipped Computer Centre, providing high end computing and training facilities. The university has been provided three 1 Gbps nodes of National Knowledge Network (NKN) under NME-ICT. Besides these, more than 100 smart classrooms have been augmented for smoothening the online teaching and learning especiallyduring the COVID times. The university has switched over to computer based entrance test and implemented ERP for executing all administrative and financial work, thereby moving towards paperless office.

#### The Temple

The Banaras Hindu University has a temple of Lord Shiva called ShriVishwanath Temple. It is situated at the centre of the campus. The temple is built with white marble. Its detailed planning was done by Malaviyaji himself. The lush campus of ShriVishwanath Temple and the beautiful gardens surrounding it are a delight to the eyes of the visitors. The interior of the temple has a Shiva Lingam, and verses from Hindu scriptures are inscribed on the walls of the temple with pictorial depiction.



#### Bharat Kala Bhavan

BHU has a museum of international importance – Bharat Kala Bhawan, which is a treasure trove of rare art and artefacts. The Bharat Kala Bhavan has 13 galleries having a collection of more than 1 lakh antique and rare sculptures, miniature paintings, Rajasthani, Mughal and Pahari paintings, coins, jewellery, precious stones, etc. Of immense historic value and a very special literary gallery containing manuscripts of famous authors. It also has a rich library containing rare books.



#### **Rajiv Gandhi South Campus**

The Banaras Hindu University has extended its outreach by establishing its South Campus at Barkachha in Mirzapur district. The RGSC is being developed as a potential hub of education, training and entrepreneurship for youth and women, especially those belonging to tribes and weaker sections of the society. The campus is being developed by the University with a mission to enrich the lives of the population of the region by extending to them opportunities to engage in life-long learning and to benefit from the result of research.

## For admission to Ph.D.– 2023

### (Candidate must ensure that they fulfil minimum essential qualification)

The Banaras Hindu University offers admission to Doctor of Philosophy / Vidyāvāridhi Degree (herein after referred to as the Ph.D. Degree programme) in various disciplines as per details given in Section - B, Table - 1.

#### A. Admission to the Ph.D. Programs will be made through the following modes-

 a) <u>Research Entrance Test (RET)-Exempted:</u> In the RET-Exempted mode those candidates will be eligible to apply who have qualified NET/JRF conducted by UGC/CSIR/ICMR/ICAR/DBT and other Government Testing Agencies/ other National Level Tests (as detailed at <u>Section G</u> of this information Bulletin).

#### b) <u>Research Entrance Test (RET):</u>

In the RET mode those candidates will be considered eligible for Ph.D. admission who have qualified the **Research Entrance Test** conducted either by BHU or National Testing Agency (NTA).

- (i) **BHU-RET:** BHU will conduct Research Entrance Test in those disciplines(<u>as</u> <u>mentioned in Table 1</u> under column 4) which are not mapped with NTA Ph.D. Entrance Test;
- (ii) NTA'S Research (Ph.D.) ENTRANCE TEST: The NTAhas conducted Research Entrance Test (hereafter referred to as NTA-RET) in the disciplines as mentioned in Appendix 1 of this Bulletin.

All vacant seats are by default available in DMC (Department in the Main Campus). In case these are available in MMV (Mahila Mahavidyala), AMPG (Arya Mahila P G College) DAV (D.A.V. P.G. College), VCW (Vasanta College for Women) and VKM (Vasant Kanya Mahavidyala) that is mentioned specifically.

#### Note:

50% of the Seats Declared (as mentioned in column 4 of Table1) shall be filled through BHU-RET – Exempted mode and remaining 50% through NTA's PhD Entrance Test (NTA-RET) or BHU-RET mode as the case may be.

Reservation roaster of the GOI (General, OBC, SC, ST, EWS, PwBD) shall be used separately for RET (BHU/NTA) and RET-Exempted category, i.e. for both modes of admission.

In case, if declared number of seat of a particular discipline is only one (1), and NTA-RET has been conducted in the discipline, then it will be filled through NTA's PhD Entrance Test (NTA-RET) mode. RET exempted candidate need not apply in such discipline. However, if the particular discipline is not in the list of NTA-RET then it will be filled through RET Exempted mode.

If the number of seats declared is more than one and in odd number(s) then after distributing the seats in equal proportion (50:50), the remaining one (1) seat will be filled through NTA-RET or BHU-RET mode as the case may be (as per the description given in point 2 above).

## C. Main Discipline – Allied Discipline Combinations For Candidates [Applicable For Ph.D. Registration Only]

To provide an opportunity for inter-disciplinary research a candidate has an option to be admitted to an allied discipline by appearing in the BHU-RET-EXEMPTED/NTA-RET/BHU – RET of related main discipline. The candidates may opt for maximum four choices for the allied disciplines (wherever applicable/available) in addition to their main discipline. The option/ preference needs to be exercised in the application form at the time of submitting application. No such request will be considered at the time of admission. It is the responsibility of the candidate to ensure that he/she is eligible for admission in the allied discipline he/she is applying for. The details of which are as under:

- i. A candidate shall be considered for admission if he / she has appeared in the NET/NTA-RET/BHU – RET of the concerned discipline in which he/she has completed Post Graduate Course and fulfils the minimum eligibility conditions (**Section D**).
- ii. In such cases, where neither NET is conducted in candidate's PG discipline nor the same is there in NTA-RET / BHU RET but the subject is mentioned in allied subject(s) (as per list at Table 1) of any of the main disciplines, then candidate may appear in the RET of any of the allied discipline closest to his / her main discipline (i.e. in the discipline in which he/she is having PG degree).
- iii. In such cases, where candidate has appeared in the NTA-RET of concerned main discipline and willing to apply in other discipline(s) through allied discipline (as per list at Table-1) but the mode of admission in that (those) discipline(s) is BHU-RET, then he/she will be required to appear in the BHU-RET in any one of those disciplines which is closest to his/her discipline.
- iv. Further, in a main discipline, the maximum number of admissions that can be given to candidates from allied discipline shall be 20% of the vacancies in the concerned main discipline. This is an upper permissible ceiling. However, if in any discipline, the vacancies are not filled up due to lack of candidates from the main discipline, students from the allied discipline may be admitted with due approval of the University Admission Coordination Board (UACB).

#### Note:

- i. **Candidates seeking admission to the Ph.D. programme are required to give their preferences of main discipline and allied disciplines to the maximum of <u>four (O4)</u> choices in the online Application Form, if available, excluding the main discipline. The choice of allied discipline is however optional and the candidate may go only for main discipline (if seat is available). The choice of discipline once indicated in the Application Form shall be final and shall not be changed subsequently on any ground. (***There can be less than 4 allied disciplines to a main discipline in which case choice will be limited to given allied disciplines only***).**
- ii. Subject to a candidate qualifying in the main discipline and/or its allied disciplines, he/she can appear in the Interview for admissions, if shortlisted, at such departments as per schedule notified or to be notified later.
- iii. For being eligible to apply for NTA-RET/BHU RET, a candidate must satisfy himself/herself that he/she fulfils the prescribed minimum eligibility requirements. In case, if it is noted at the time of admission that a candidate has qualified examination but does not fulfil the eligibility, his/her candidature will not be considered.

## The University reserves the right to withdraw any seat(s) / admission of the discipline in case of any exigency.

#### D. Minimum Eligibility Requirements for Qualifying Examination & Percentage of Marks:

#### D.1. For Admission To Ph.D. Programmes:

A candidate must have (a) passed the qualifying examination securing the minimum percentage of marks on the last date of filling of online application of NTA-RET/BHU - RET/ BHU-RET-Exempted 2023.

(ii) M.Sc. in the concerned subject

(iii) Master's degree in any one of the allied subjects.

(B) Qualifying Marks: At least 55% in aggregate or equivalent grade point average in the qualifying examination.

#### 3. Faculties of Arts, Social Sciences and Science:

#### (A) Qualifying Examination:

Master's degree in the concerned subject OR (ii) Master degree in any one of the allied subjects. However,

- (i) for admission to Ph.D. in Subaltern Studies candidates holding M.Phil. degree in Subaltern Studies would be eligible. Candidates who have done M.Phil.in Subaltern Studies from the Banaras Hindu University shall be considered for direct admission to Ph.D. in Subaltern Studies without appearing in the NTA-RET/BHU-RET. However, such candidates who have obtained the M.Phil. from other Universities are required to appear in the NTA-RET/BHU-RET for Subaltern Studies.
- (B) Qualifying Marks: At least 55% in the aggregate or equivalent grade point average in the qualifying examination.

#### 4. Faculty of Performing Arts:

(A) Master's degree in the concerned discipline from a recognized University

OR

Master's degree in any discipline and having passed any one of the following examinations other than Performing Arts:

**(B)** Qualifying Marks: At least 55% in the aggregate or equivalent grade point average in the qualifying examination.

- (A) Qualifying Examination: Acharya degree in the concerned subject **OR** Acharya or equivalent degree in any one of the allied subjects.
- **(B) Qualifying Marks:** At least 55% in the aggregate or equivalent grade point average in the qualifying examination.

#### 6. Faculty of Commerce:

- (A) Qualifying Examination: Master's degree in Commerce (M.Com.)/Master of Finance and Control (M.F.C.)/ Master of Financial Management (MFM) / Master of Risk and Insurance Management (MRIM)/ Master of Financial Management (Risk & Insurance) (MFMRI)/Master of Foreign Trade (MFT)/Master of Business Management (M.B.M.), Master of Business Administration OR in allied areas namely, M.A. in Economics/ Psychology, Chartered Accountancy (C.A.) of the Institute of Chartered Accountants of India, Costs & Works Accountancy of the Institute of Costs & Works Accountants of India (I.C.W.A.I.), the Company Secretary ship of the Institute of Company Secretaries of India (I.C.S.I.).
- (B) **Qualifying Marks:** At least 55% in aggregate or equivalent grade point average in the qualifying examination.

#### 7. Faculty of Management Studies:

- (A) Qualifying Examination: Master's degree in Business Management (M.B.M.), Management Studies/ Management Sciences (M.M.S.), Business Administration (M.B.A.), International Business Administration (M.I.B.A.), International Business (M.I.B.), M.B.A. (Agri-Business) ORtwo year PGP/PGDM declared equivalent to Master's Degree in Management by AIU/accredited by AICTE/UGC or First class graduate and professionally qualified Chartered Accountant/Cost and Works Accountant/Company Secretary of the concerned statutory bodies. Candidates having any of the aforesaid degrees are eligible to apply for the main discipline of Management studies.
- (B) Qualifying Marks: At least 60% in the aggregate or equivalent grade point average in the qualifying examination.

#### 8. Faculty of Law:

- (A) **Qualifying Examination:** Master's Degree in the concerned discipline.
- (B) **Qualifying Marks:** At least 55% in the aggregate or equivalent grade point average in the qualifying examination.

#### 9. Faculty of Education:

 (A) Qualifying Examination: M.Ed./M.A. (Education)/ Master's degree in Special Education [M.Ed. (Spl.)] / OR (ii) Master's degree in any one of the allied subjects (B) **Qualifying Marks:** At least 55% in aggregate or equivalent grade point average in the qualifying examination.

#### **10. Faculty of Medicine:**

- (A) Qualifying Examination: Doctor of Medicine (M.D.)/ Master of Surgery (M.S.)/ Doctoratus of Medicinus (D.M.)/ Magister Chirurgiae (M.Ch.)/ Diplomate of National Board (D.N.B) in the concerned subject recognized by the Medical Council of India. OR M.Sc. in the concerned subject OR Master's degree in any one of the allied subjects.
- (B) **Qualifying Marks:** At least 55% in aggregate or equivalent grade point average in the qualifying examination (wherever the marks/grades are awarded).

For admission to Ph.D. in CEMS, a candidate(s) must hold Master's Degree in any one of the allied subjects.

#### 11. Faculty of Ayurveda:

- (A) **Qualifying Examination:** M.D.(Ay.) / M.S.(Ay.) recognized by Central Council of Indian Medicine (CCIM). **OR** Master's degree in any one of the allied subjects.
- (B) **Qualifying Marks:** At least 55% in aggregate or equivalent grade point average in the qualifying examination.

#### **12. Faculty of Dental Sciences:**

- (A) **Qualifying Examination:** Master's Degree in Dental Surgery or Master's degree in any one of the allied subjects.
- (B) **Qualifying Marks:** At least 55% in aggregate or equivalent grade point average in the qualifying examination (wherever the marks/grades are awarded)

#### **13. Faculty of Visual Arts**:

- (A) **Qualifying Examination:** Bachelor's degree in Fine Arts under four year course and Master's degree in Fine Arts: MFA in applied Art **OR** MFA in Plastic Arts (Sculpture) **OR** MFA in Painting **OR** in Textile Design **OR** MFA in Pottery Ceramic.
- (B) **Qualifying Marks:** At least 55% in aggregate or equivalent grade point average in the qualifying examination.

#### 14. Faculty of Enviornment& Sustainable Development:

- (A) **Qualifying Examination: Essential:** A candidate having Master's degree in the concerned subject **OR** Master degree in any one of the allied subjects, provided the candidate has opted at least one paper related to environment and/or sustainable development.
- (B) **Qualifying Marks:** At least 55% in aggregate or equivalent grade point average in the qualifying examination.

#### NOTE:

(i) A candidate appearing in NET/NET-JRF may also apply for the Ph. D. programme provided the result of the NET/NET-JRF examination is **declared before the last date of submission of online application form in the University portal** and the candidate fulfils other eligibility criteria for admission to the Ph.D. programme.

- (ii) If the applicant has passed the qualifying examination where grades are awarded and:
  - a. Where the Grade Sheet does not mention the equivalent percentage of marks from grade points, the candidate should submit such a Certificate of conversion from the concerned Institution mentioning either the converted percentage, or the formula for the actual conversion of grade point average to percentage of marks.
  - b. Where the Grade Sheet itself mentions the equivalent percentage of marks from grade points, or the formula for such conversion, the candidate should get both sides of the Degree/Grade Sheet photocopied showing the equivalent percentage of marks/conversion formula and enclose with the Application Form.
  - c. In case there is no conversion formula for computing the percentage, CGPA (out of 10) multiplied by 10 will constitute the percentage. In case where the CGPA is available only out of 4, then CGPA multiplied by 25 will constitute the percentage. In case of any confusion suitable conversion/scaling shall be done to compute the percentage based on the upper limit of the CGPA of the concerned discipline. Department will seek approval of the University Admission Coordination Board in this regard.
- (iii) "Aggregate percentage of marks" will include grace marks awarded to a candidate.
- (iv) A candidate already possessing a Ph. D. degree of this or any other University shall be eligible to be admitted to the Ph. D. programme for an additional Ph. D. degree in a subject other than the subject in which he/she already possesses the Ph. D. Degree. The admission of such a candidate will be at the discretion of the Vice-Chancellor, who, on the basis of specific recommendation and full justification by the Departmental/School Research Committee (DRC/SRC) after considering certain relevant criteria such as, the synopsis of the proposed topic, relevance of the proposed topic and its relationship with the topic of the first Ph. D., etc. will take a final decision.

## Applicant must satisfy himself/herself about fulfilling the minimum eligibility requirements as prescribed above before filling the Application Form.

#### Note:

- (i) Any degree mentioned under the qualifying examination for each Faculty in the above sections (D.1) pertains to the degree awarded by this University or any other University established by law for the time being in force or any other degree recognized as equivalent thereto in that subject.
- (ii) Candidates belonging to SC/ST/PwD/OBC categories may see the provisions on relaxations given at Section E.

#### E. Reservations and Relaxations:

#### E.1. Scheduled Castes/Scheduled Tribes:

- Reservation shall be applied considering discipline as a unit (e.g. if there are 20 seats in all, out of which DMC in Psychology has 13 seats, MMV has 4 seats and VCW has 3 seats, then reservation will be calculated on 20 seats.)
- Seats shall be reserved for Scheduled Caste (15%) and Scheduled Tribe (7.5%) candidates in each discipline/programme. Admission against these seats will be made provided the candidate has passed the Qualifying Examination and qualifies NET/NTA-RET/BHU-RET as provided in **Section D** of this Information Bulletin.
- Each SC/ST candidate shall have to submit a self-attested copy of the Certificate mentioning that the candidate belongs to SC/ST community. Such certificates shall be subject to verification from the concerned District Magistrate.
- SC/ST Certificate should be issued by the competent authority as per the GOI norms

- If the candidate happens to belong to SC or ST, his/her caste/tribe must be listed in the appropriate Govt. of India schedule. The Caste Certificate should clearly state: (a) Name of his/her caste/tribe (b) whether he/she belongs to SC or ST (c) District and the State or Union Territory of his/her usual place of residence and (d) the appropriate Govt. of India schedule under which his/her caste/tribe is approved by it as SC or ST.
- If a candidate seeks admission under some other category (for example: PC etc.) the candidate should satisfy the minimum eligibility requirement for that category.

#### E.2. Other Backward Classes (OBCs):

27% Reservation shall be given as per GOI rules to candidates belonging to OBC category (excluding under creamy layer) in different programmes. The authorities to issue the OBC shall be as per the GOI norms. The caste in the OBC certificate will be those only which are in the list of Central Govt. Further the **OBC certificate should clearly mention that the candidate is not under creamy layer**. However, if an OBC candidate seeks admission under some other category (for example: PwBD etc.) the candidate should satisfy the minimum eligibility requirement for that category.

#### E.3. Economically Weaker Sections (EWSs):

In accordance with O.M.F.No.12-4/2019-U1 dated 17<sup>th</sup> January 2019 of the Department of Higher Education, MHRD, Government of India, 10% reservation for Economically Weaker Sections shall be provided in admission during the Academic Session 2023-24.The prospective candidates who are claiming under EWS category may fill their EWS category at the time of registration and filling of online application of BHU-RET/BHU-RET-Exempted 2023.

The benefit of reservation under EWS can be availed upon production of an "EWS Certificate" issued by a Competent Authority as per GOI norms.

#### E.4. Persons with Benchmark Disability (PwBD):

5% seats shall be reserved for Persons with Disability Candidates on horizontal basis in following manner: (a) blindness and low vision; (1%) + (b) deaf and hard of hearing; (1%) + (c) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (1%) + (d) autism, intellectual disability, specific learning disability and mental illness; (1%) + (e) multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts identified for each disabilities: (1%) (on horizontal reservation basis). Such candidates will have to submit a self-attested copy of Disability Certificate issued by the District CMO/Civil Surgeon/ Medical Superintendent of a Government Health Care Institution with the Application Form as per prescribed proforma. **Candidate shall have to appear before the Medical board of the University for Examination and the decision of the Board as regards the disability of the candidate will be final.** 

# E.5.Relaxation in Minimum Percentage of Marks/Academic Record for Scheduled Castes (SC)/Scheduled Tribes (ST) / Persons with Disabilities (PwBd) / Other Backward Classes (OBCs) Candidates:

There shall be relaxation in minimum percentage of marks for certain category of candidates. The relaxation shall be as shown in the table-

However, a Physically Challenged (PC), SC/ST/OBC candidate shall not get the double benefit of being SC/ST/ OBC as well as PC candidate in the above relaxations.

#### E.6. Consideration of Reserved Category Meritorious Candidates as General Candidates:

In a discipline/programme, if the merit of a reserved category candidate is more than or equal to the merit of the last admitted unreserved candidate in that course, the reserved category candidate will be treated as unreserved candidate in that course. Provided further that if a meritorious reserved category candidate is admitted by relaxing the general qualifying standards (minimum eligibility requirement and/or age) which he/she would not have got by remaining under the general category, then his/her admission shall be adjusted against the concerned reserved category quota and the consequential vacancy created in the general category shall be filled up by a general category candidate in order of merit. However, he/she have the privilege in hostel allotment.

#### **General Notes:**

- 1. Notwithstanding anything contained in the Ph.D. Ordinances, the eligibility requirements for the purpose of admission shall be only those which are mentioned in the Information Bulletin of the academic session concerned.
- 2. All Ph. D. Scholars shall be governed by the Ph. D. Ordinances.
- 3. The candidate shall be bound by BHU Statutes/Ordinances/Rules and Regulations framed from time to time.

#### F. General Rules:

- (i) A candidate who satisfies the requirements mentioned in **Section D** should apply on the prescribed online Application Form for admission to the concerned programme.
- (ii) Application Forms of candidates who have submitted forged/fake certificates or adopted fraudulent means shall be REJECTED. Further, such candidates shall be debarred from any future admission(s) as well as employment in BHU.
- (iii) If any debarred student is found to get admitted in any discipline, his/her admission will be cancelled at any point of time by the University.
- (iv) Candidates are allowed to appear at the NTA-RET/BHU-RET/ provisionally subject to the final verification of Mark sheets/Degrees/Certificates, validity of Certificates/Mark sheets of Qualifying Examination and also of involvement in the adoption of unfair means in any of the University Examination/Entrance Tests held earlier, at the time of admission. Degrees/Certificates recognized by Association of Indian Universities (AIU) shall only be deemed as equivalent degrees/certificates.
- (v) The Distance Education Council of Indira Gandhi National Open University (IGNOU)/Association of Indian Universities (AIU) is the only authority to recognize the Degrees/Certificates of Distance Education. Such Candidates are **provisionally** permitted to appear in the NTA-RET/BHU-RET/ and will be required to submit certificates from Distance Education Council of IGNOU, New Delhi regarding recognition/approval of the courses.
- (v) Mere appearance in the Entrance Test or securing pass marks at the NTA-RET/BHU-RET/ does not entitle a candidate to be considered for admission to a discipline/programme unless he/she fulfils the eligibility conditions. APPLICANTS MUST FULLY SATISFY THEMSELVES ABOUT THEIR ELIGIBILITY AS PRESCRIBED ABOVE, BEFORE FILLING IN THE APPLICATION FORM. If any applicant who is inadvertently allowed to appear at the Entrance Test but otherwise does not fulfil the minimum eligibility requirements, he/she cannot, at a later date, use that as a right to claim that he/she meets the eligibility requirements. The University reserves the right to cancel/refuse admission at any point of time if it is found that:
  - (a) Minimum eligibility requirements are not fulfilled.
  - (b) False documentation has been done.
  - (c) Any other similar valid reason.

- (vi) Candidates appearing at the **NTA PhD Entrance Test (NTA-RET)/BHU-RET** shall be subject to Rules, Regulations and Ordinances relating to the University examinations. Candidates found adopting unfair means shall be liable to punishment as per University rules.
- (vii) Final Decision in Case of Any Dispute
  - a. In case of any dispute relating to the **NTA-RET/BHU-RET**/admission to Ph.D., the decision of the DRC/SRC shall be final. An appeal may lie to the Vice-Chancellor, BHU against such decision. In no case any candidate shall take recourse to the court of law directly.
  - b. In case of any litigation relating to the **NTA-RET/BHU-RET** admission to Ph.D./M-Phil course, the District Court of Varanasi and the High Court of Judicature of Allahabad shall only have the jurisdiction.

Notwithstanding anything to the Contrary Contained Anywhere in the Ordinances of the University, No Scrutiny/ Re-Evaluation of the Answer sheet of BHU-RET shall be allowed on any ground. Further, no representation or query regarding the conduct of the test shall be entertained.

G. Direct Admission (Without appearing in NTA-RET/ BHU-RET, i.e., under RET Exempted category: This is applicable for admission to various Ph.D. programmes)

A candidate who fulfils one of the following requirements may be considered for mission to the Ph.D. without appearing in the NTA-RET/BHU-RET:

- i. A candidate who has qualified in a national level test such as National Eligibility Test (NET-JRF), NET-LS (without fellowship), Graduate Aptitude Test for Engineering (GATE).
- ii. If any candidate comes up with a Nationally or Internationally renowned Ph.D. scholarship the value of which is at par or greater than UGC/CSIR JRF, then he/she shall be given Ph.D. admission under supernumerary quota.
- iii. A candidate who is selected under Quality Improvement Program (QIP) of AICTE, Faculty Development Programme of a State Government or of UGC.
- iv. A foreign national who is a recipient of fellowship by Indian Council for Cultural Relations (ICCR), Government of India and who is sponsored by his/her government.

#### Note: Following additional criteria must be noted for a foreign national

- a. The equivalence of the degree possessed by the foreign candidates belonging to the Clauses IV.1 (b) (v) and (vi) of the Ph.D. Ordinance, shall be settled by the equivalence committee of the concerned faculty before their admission. They shall be admitted to the Ph. D. programme only if the degree possessed by them entitles them for enrolment as Ph. D. scholars in the universities of their own countries.
- b. English Proficiency certificate of TOEFL (minimum 70 marks) or IELTS (minimum 6 bands) score is mandatory for foreign candidates at the time of submission of application form for the admission in the University. If the candidate is unable to provide any of these scores/certificate or English Proficiency certificate then the candidate will be asked to appear in the English Proficiency test to be conducted by Office of the Controller of Examinations. He/she has to clear Intermediate level course and need an overall minimum score of 40% to confirm admission.
- c. The aforesaid provision may be relaxed for candidates having nationality of English speaking countries or who have passed their qualifying degree from the Institution with English as medium of instruction.

- d. The supernumerary quota for self-financing foreign nationals shall be restricted to a maximum of 15% of the total available Vacancies in a Department/ School.
- e. A self-financing foreign national is one who is admitted through the Embassies/High commission of his/her country or admitted under a MoU with due clearance from the Indian Missions abroad. As per revised guidelines/ instructions of the Department of Higher education, MHRD, GOI on grant of research visa, the foreigners who desire to undertake research in India, should therefore, apply to the concerned Indian Missions abroad with the brief synopsis of the research project to be undertaken in India, the details of places to be visited, previous visits, whether the scholar has secured admission into a recognized or reputed institution and evidence of financial resources.
- f. Indian Missions abroad with the brief synopsis of the research project to be undertaken in India, the details of places to be visited, previous visits, whether the scholar has secured admission into a recognized or reputed institution and evidence of financial resources.
- v. A candidate who is already registered as a Ph. D. scholar in some other university and whose supervisor joins this University.
- vi. A candidate occupying senior management position in a government department/ public sector undertaking/ private industry (of repute and belonging to the top management of the firm), equivalent to pay matrix level -12, which is not recognized as centre of research by the University, may be admitted to the Ph.D. programme with prior approval of the Vice Chancellor provided he/she has at least 12 years of professional experience and has minimum age of 43 years. He/she must be sponsored as a part-time candidate by the said organization and the concerned DRC must be convinced that the candidate can effectively pursue his/ her Ph.D. work in his/her parent organization. Fulfilling 45 days per academic year (1<sup>st</sup> July to 30<sup>th</sup> June) of the residency period (physical presence on the campus and in the department) shall be mandatory for the candidates seeking admission under the aforesaid clause. The candidate is required to submit a No Objection Certificate as well as work experience certificate from the parent organization.
- vii. A candidate, working in an externally funded research project in the University as a research personnel, may be allowed to register for Ph.D. in the University provided he/she publishes at least one research paper in peer refereed journals after joining the project (out of the research work generated in the project) or he/ she gets short-listed in BHU-RET conducted by the University. Provided further that in such cases, the consent of the PI and the supervisor (in case PI is not the supervisor) is available to the effect that the research work of the Project and that of the Ph.D. are overlapping and/or working in both simultaneously will not hamper the interest of either.
- viii. A teacher of the University or of the constituent / affiliated colleges of the University holding substantive post (including those on probation)
- ix. A non-teaching permanent employee of the University holding substantive post, having outstanding performance in service besides having extraordinary academic records, shall be considered

Candidates meeting any of the aforesaid provisions and other condition(s) prescribed under Section-D (Minimum Eligibility Requirements for Qualifying Examination & Percentage of Marks) are not required to appear in the NTA-RET/BHU-RET of the concerned discipline/programme. However, all the exempted candidates will have to appear in the BHU Research Ability Test to be conducted for BHU RET Exempted Category candidates. These candidates will also have to appear in the interview. They must apply in the prescribed online Application Form in order to be eligible for consideration for admission. The applications of the candidates belonging to the categories (iii) to(x) above should be routed through proper channel.

#### H. Structure of Ph.D. Admission Test 2023:

The Ph. D. admission 2023 will be given on Merit based on total marks/scores of 100 that will come from three components as noted below.

#### BHU-RET/ Research Ability Test-

- (a) Research Entrance Test namely, BHU-RET and Research Ability Test (For RET Exempted candidates) shall be held **tentatively in the month of December 2023**.
- (b) Both the tests will be conducted in the **Pen-Paper Mode**.
- (c) **BHU-RET Test Centres** BHU-RET for all discipline will be held in Centres at Varanasi. New Delhi, Mumbai, Kolkata and Chennai shall also be Test Centres provided the number of examinees on a particular centre on a particular shift is minimum hundred.
- (d) The Research Ability Test for RET exempted candidates will be held only at Varanasi Centre.
- (e) The Exact Date of the Tests, Test Centres, Procedure, Provision for Scribe in case of PwBD candidates etc. shall be Notified Later and details will be put on the website <u>www.bhuonline.in</u>. Candidates are advised to visit the website regularly for updates.

#### 3. Interview:

All eligible candidates on the basis of entrance test/Written Examination marks will be called to appear in an interview in the Department/Centre of concerned discipline. The maximum marks for interview will be 25. The calling procedure is noted below in **Table-6**.

#### Interview:

- (i) The candidate is required to appear before an interview board of the concerned discipline/department. The Board will evaluate his/her research ability as per the different domains of thrust area of the department.
- (ii) For Faculty of Visual Arts and Performing Arts where practical knowledge and expertise of the applicant is crucial to decide his/her suitability as Ph.D. scholar, the interview can be converted into practical examinations. For this the Faculty PPC should take formal approval from UACB well in advance. The system of marking will remain same as in case of interview.

#### J. How to Apply

The University has created its Entrance Test Portal with the domain name <u>www.bhuonline.in</u>. Its link is also available on the BHU website (<u>www.bhu.ac.in</u>). The BHU-**RET 2023 Information Bulletin is available on BHU portal. The application Form for BHU RET and for exempted category shall be available on the BHU website shortly. The entire process of making BHU-<b>RET 2023** application for admission in various disciplines/programmes during the academic session 2023-24shall be made ONLINE. Accordingly, candidates may note that BHU-**RET**2023 Information Bulletin and Application Form will not be sold (as there will be no offline mode) and the candidates desirous of admissions shall be required to register on the Entrance Test portal of BHU and fill up the application form ONLINE as per procedure provided on the Portal. For further details visit the BHU website (<u>www.bhu.ac.in</u>) or the entrance test portal of BHU (<u>www.bhuonlne.in</u>).

(i) The Application Processing/ Entrance Test Fee paid shall neither be refunded nor transferred to another Disciplines and shall also will not be reserved for any subsequent year, in any case.

#### J.2. Mode of Payment of Application Processing/Test Fee:

Candidate is required to fill up the BHU-RET 2023 Application Form ONLINE as the printed Information Bulletin-cum-Application Form will not be sold by the University. After the candidate has filled up the application form online, he/she will have to make **online payment** of Application Processing/ Entrance Test Fee **through credit card/ debit card** through the payment gateway available on the Entrance test portal.

#### J. 3. Instructions for Submission of Application Form:

- a) J.1 Online Application Form for the Applicants of BHU-RET/RET Exempted -2023: The Application Form for BHU RET/RET-Exempted 2023shall be available on the BHU's entrance test portal (www.bhuonline.in). The online application making process will have following six stages:
  - Step 1: Registration on the Portal [www.bhuonline.in] This step involves authentication of Candidate's email id and mobile number. As all important communications related to Entrance Test and Admission will be sent to the registered email id and mobile number, candidates are advised to give their correct email id/ mobile number (in use).
  - Step 2: Filling up Identification details Only after successful registration on the Portal [www.bhuonline.in], the candidates would be required to fill up an Identification Form giving particulars of the documents for authentication of their identity. For the purposes, following photo identification documents are allowed: (i) Aadhaar Card; (ii) Passport; (iii) Voter ID issued by the Election Commission of India; (iv) Bank Passbook affixed with the photograph (v) Driving License; (vi) Pan Card; (vii) any other valid Government ID Number and (vii) Admit Card issued by the concerned Boards. Candidate should carefully write the correct spelling of their names as carried in their Aadhaar/identification document (as applicable). The candidates shall be compulsorily required to carry their identification document (as provided in the application process) to the examination centre/interview centre, authentication of their identity, alongwith the Entrance Test Admit Card (wherever applicable), failing which such candidate shall not be allowed in the examination hall.
  - Step 3: Online Application Form Entry and Selection of Discipline- After successfully entering identification details, the candidates are required to fill-up details in the online application form and select the discipline after ensuring their eligibility for the concerned discipline in which they are desirous of taking admission.
  - Step 4: Uploading of photographs and signature- Candidates have to scan their photo and signature as per instruction given in the portal and upload it.
  - Step 5: Payment of Application Processing/ Entrance Test Fee- After the candidate has filled up the application form online and clicks on the "CONFIRM" button, he/she will have to make the payment of application processing/test fee in online mode using credit card/ debit card/net banking/etc. through the payment gateway available on the Entrance test portal.

NOTE:

✓ The candidate is required to check the status of fee payment at BHU website (www.bhuonline.in) and if the status is 'OK', then only candidate will be able to take printout of Confirmation Page. In case, the fee payment status does not show the payment id/ OK status, the candidate is advised to act as follows:

- ✓ If the fee is paid through credit/debit card and status is not OK, it means the transaction is cancelled and the amount will, automatically, be refunded to concerned credit/debit card within 7 10 days. Therefore, such candidate has to pay the fee afresh and ensure the OK status within the last date for submission of online application form.
- Step 6: Printout of Application Form for the record of candidates After online submission of application form and successful payment of Application Processing/ Test Fee, candidates are advised to take a printout of the online filled up application form (containing the details he/she has filled in and the transaction details of payment of application fee) from either the Entrance Test portal for their own record.

#### NOTE:

- 1. The application form is to be filled up and submitted online with due care. Detailed instruction for filling up the application form, online payment of application fee and online submission shall be provided on the BHU's Entrance Test portal.
- 2. The BHU-RET and Exempted Application Form shall be treated to have been successfully submitted after the candidate has paid the Application Processing Fee/ Entrance Test Fee only through the modes given above at Step 5.
- 3. After submission of the online application form the category change in any respect shall not be allowed in any case.

**IMPORTANT NOTE:** Notifications relating to Conduct of Test/ Display of Provisional Key etc. will be made on BHU Entrance Test Portal:(<u>www.bhuonline.in</u>) only. **The candidates are therefore advised to regularly visit the said website for updates.** 

#### K. Reasons For Rejection of the Application Forms:

- (i) Submission of application form without payment of requisite amount of Application Processing/ Entrance Test Fee.
- (ii) Any other inadequacy detected.

**NOTE:** If at any stage it is found that the applicant is not eligible for admission in a discipline under University rules, his/her candidature will automatically stand cancelled. Please note that thorough checking of Application Form, Minimum Eligibility requirements, Original documents in support of Academic Certificates and Categories-claimed will be done only at the time of admission/counselling (if called for the same). At that stage also the candidature of the applicant will stand cancelled, if he/she does not fulfil all the requirements for admission.

#### L. IMPORTANT DATES and COUNSELLING PROCEDURE:

The University Admission website <u>www.bhuonline.in</u> will provide details of the registration date and deadlines after opening of the registration which is going to be live shortly.

## L.1. Counselling Procedure on the Counselling Date, Publication of Result, Payment of Fee and Allotment of Supervisor

There shall be computerised counselling procedure for admissions to the PhD Program during the academic session 2023-24. The counselling procedure will involve following steps:

a. Attendance of Candidate: Every candidate called for interview for admission to a discipline shall be required to reach the counselling venue at the prescribed time/date given in the Call letter. He / She should contact the Head of the Concerned Department/Admission In-

charge PhD and mark his/her attendance by signing the attendance sheet available with the Counselling Centre In charge.

**b.** Verification of academic records of the Candidates: The Admission Committee (Teacherscounsellors) available at the Department/Venue shall physically verify the Academic Records of the candidates.

#### c. Conduction of interview of the Candidate(s):

- (i) Thereafter the interview will be conducted in the concerned department/school/centre by the Department which carries a total of 25 marks for personal interview.
- (ii) A candidate applying in more than one discipline will appear at <u>interview separately</u> in each of the disciplines in which he/she has applied and qualified. The dates for **interview** may be suitably adjusted /staggered in different disciplines, provided that the candidate makes a written request for the same.

#### d. ADMISSION PROCESS

#### (i) DECLARATION OF RESULTS

Names of as many candidates as the number of vacancies given in the Information Bulletin will be announced on the basis of final merit order prepared. An equal number of wait-listed candidates (in order of merit) will also be prepared for consideration in case seats remain vacant.

#### f. Admission, Allotment of Ph.D. Supervisor and Payment of Fee

Based on the final merit order, the Central Admission Committee would release/ publish the NTA'S PhD Entrance Test (NTA-RET)/BHU-RET-2023and BHU-RET – Exempted – 2023merit list of the candidates who are declared qualified for the said disciplines. The candidates may be advised to see the course allocation page on their portal on the counselling day and thereafter. In case a candidate is offered provisional admission, he/she <u>must make payment of the admission fee before the deadline of fee payment given in</u> <u>the course allocation page</u> of the portal failing which he/she shall forfeit his/her claim for the provisional admission and the said offer of admission will stand withdrawn.

#### L.2 Payment of Fee:

**Candidates receiving Offer of Admission will have to pay the fees Online** (through Debit Card/Credit Card/Net banking) through the payment gateway available on the Portal.

#### NOTE

- (i) For online payment, the candidate must visit Course Allocation page and make the payment through debit/credit card, etc.
- (ii) A candidate will be treated as provisionally admitted in the course offered only after the prescribed fee has been paid by him/her. On successful payment of prescribed admission fee, the payment ID will appear in the 'Application' page of the candidate's portal as well as in the admitted list available on the admission committee site of the portal. Further, the provisional admission of the candidate to the concerned programme shall be subject to such Ordinances, Rules and Regulations as may be framed from time to time by the University.
- (iii) However, if a candidate, on declaration of final merit list, stands selected for admission in more than one discipline, he/she shall be allowed to take admission in only one of the disciplines based on his/ her choice/ preference and merit in the discipline. He/she has to secure admission by submitting the fee online. Once he/she submits fee in one discipline, offer of admission in other discipline will be withdrawn. The candidates are therefore

required to make a conscious decision as no request to change the discipline later will be entertained at any cost.

(iv) Candidates can download the Admission letter from their portals only after the admissions are over in the concerned discipline or they have locked their allotment after any round of declaration of admission list. The admission letter will contain the date on which they have to report to the concerned Department/Centre/School for their Ph.D. program along with the required documents.

#### L.3 Allotment of Supervisor:

The Department(s) ought to clearly display the number of vacancy(ies) (as mentioned in the BHU-RET Information Bulletin 2023) and area of specialization of the teachers under whom the vacancy(ies) exists. The allotment of Supervisor will be done by the concerned DRC/CRC/SRC for those who have secured admission by depositing the admission fee. Thereafter, the DRC/CRC/SRC may call the Ph.D. student, in order of merit, and allow him/her to choose his/her supervisor according to his/her preference subject to availability of vacancy under different supervisor(s) and their specialization area. Allotment will be made under those Supervisors only for whom the DRC has sent vacancies to the Office of the Deputy Registrar, Academic. Further, the said DRC/CRC/SRC will formally allot a Ph.D. Supervisor, [and Co-Supervisor(s), if required], for the selected/allotted candidates on his/her proposed research topic. The DRC/CRC/SRC will send/upload the complete list of students admitted under their PhD program along with the Supervisors allotted to them within 15 days of the publication of result.

**M. Registration of Foreign Nationals:** Applications of Foreign Nationals nominated by the Govt. of India under scholarship scheme and self-financing Foreign Nationals shall be entertained. The foreign nationals **need not appear in the entrance test** for admission. However, they should have passed *the equivalent Qualifying Examination from an Indian or Foreign University / Institution.* 

Provision to the extent of 15% of the total Vacancies in each Discipline on supernumerary basis for Foreign Nationals is available: Out of which 5% Vacancies be filled up by children of NRIs [Persons of Indian Origin (PIO)] and 5% by children of Indian workers in Gulf and South Asian Countries. All the foreign nationals have to fulfil the following conditions:

#### A. At the time of submitting the application

- (i) All the foreign nationals should submit their applications, along with the **processing fee**, on prescribed format, which can be freely downloaded from the website **www.bhu.ac.in**.
- (ii) The applications of scholarship-holding Foreign Nationals (under various schemes) are routed through the Indian Council for Cultural Relations/Ministry of Human Resource Development (Department of Education), Govt. of India, New Delhi.
- (iii) They should hold a valid foreign passport.
- (iv) The antecedents of the candidate have been verified by the forwarding Agencies/Ministry and found in order.
- (v) They should have adequate knowledge of English and/or Hindi as per the requirements of the Course.

#### B. At the time of admission

(i) As per revised guidelines/ instructions of the Department of Higher education, MHRD, GOI on grant of research visa, the foreigners who desire to undertake research in India, should therefore, apply to the concerned Indian Missions abroad with the brief synopsis of the research project to be undertaken in India, the details of places to be visited, previous visits,

whether the scholar has secured admission into a recognized or reputed institution and evidence of financial resources.

- (ii) They have valid Residential permit in India granted for studies/Student Visa for the prescribed duration of the concerned Course.
- (iii) They fulfil the minimum eligibility requirements.

#### C. General

- (i) The Degrees/Certificates of the candidates have been recognized and approved by the Association of Indian Universities (AIU)/Commonwealth Universities/International Association of Universities (IAU) as equivalent to the corresponding Indian Degrees/Certificates.
- (ii) All the eligible foreign nationals are required to fill up the Registration Form prescribed by the University at the time of admission.
- (iii) The *inter-se* merit among the applicants of various foreign nationals will be decided by the "Core Committee for Admissions of Foreign Nationals", which shall be deemed as final.

Further details regarding admission of foreign nationals are available on the website **<u>www.bhu.ac.in</u>** which is updated periodically.

#### The applications should be submitted to the INTERNATIONAL STUDENTS CENTRE, C/3/3 TAGORE HOUSE, BANARAS HINDU UNIVERSITY, VARANASI - 221005, INDIA on or before the last date as notified by the International Students Centre.

#### FEE FOR THE FOREIGN NATIONALS:

Fee structure for all the categories of foreign nationals is as under (Fee details available on website)

- 1. Processing fee (50 / 100 US \$) : At the time of submitting the application
- 2. Usual Course fee (in INR) : At
- : At the time of joining the course
- 3. Additional fee (US \$) : At the time of join
  - : At the time of joining the course

The quantum of processing fee and additional fee may be modified by BHU from time to time.

#### N. Fellowship:

All the eligible internal full-time research scholars (admitted through BHU-RET) and not getting any financial assistance from any funding agency may be provided fellowship for his/her full residential period (maximum three + one years as per Ph. D. Ordinance). However, the extended period of fellowship (fourth year) shall be subject to submission of evaluation report after three years through the Research Programme Committee (RPC) and Departmental Research Committee (DRC) to be finally approved by the Vice-Chancellor. Further, a research scholar earlier admitted under BHU-RET exempted category (NET-LS/GATE only) could be extended BHU research fellowship subsequently, subject to fulfilment of certain conditions prescribed in the Ph.D. Ordinances.

#### **Important Note:**

The students who would be assigned to register themselves for Ph.D. in the Colleges admitted to the privileges of the University would have to **carry out their research work in the concerned college only**. Their fees shall be deposited in the concerned college. The concerned College shall be liable for payment of all kinds of fellowships to students registered with them and the Banaras Hindu University will not provide any fellowship or hostel or medical or library facility to those registered for Ph.D. in Colleges admitted to the privileges of the University.
